Wardrobe: For routine and regular cleaning, Norix® recommends the use of Simple Green® or an equivalent cleaning product with a soft damp cloth. Prodigy® products are suitable for use with hospital-grade disinfectants (such as Virex®, Wexcide® or Oxivir Five 16®) per manufacturers' instructions.

SafeDoor®: Use Simple Green® hospital-grade cleaner or bleach & water solution on the entire door. Completely rinse with clean water (do not submerge) & wipe with soft damp cloth. Do not use a brush as that may scuff the image.

Installation

Proprietary ligature resistant floor and wall anchoring system with concealed hardware (the anchoring mechanisms are included, the anchoring hardware is NOT included). Please consult contractor or facility management as necessary. Tamper-resistant non-removable steel encased floor glides are included and may be field installed. Security caulk may be applied to the perimeter after anchoring.

*Normal Neodymium magnets will lose their magnetic properties if heated above 175°F (80°C). The strong magnetic fields of neodymium magnets can damage items such as television, computer monitors, credit cards, bank cards, computers, diskettes and other data carriers, video tapes, mechanical watches, hearing aids, loud speakers and VCRs. Pace-makers may be damaged or switch to "Test Mode" in the presence of a strong magnetic force, if a pace-maker or other electrical body implant is in use, keep a minimum of 3 feet (0.9 m) distance.
